



**CERTIFICATE OF ELIGIBILITY FOR SPONSORSHIP BY AN EMPLOYER

**FOR OCCUPATION CODE 2131 IT Project manager – Implementation Manger**

Passportia assessed Mr Virat Singh in relation to the above occupation code and information he provided overleaf.

**He is eligible to be sponsored as a Skilled Worker for a job matching this code, and to be granted a visa to enter the UK according to the information supplied and provided the other requirements are met.**

He would need to be offered a job and sponsorship by a UK company or other organisation with a Skilled Worker sponsor license, and the Home Office would need evidence that the requirements are met. The government fees are shown overleaf. The minimum salary to be paid for this occupation code is:

Salary will scale with hours per week, subject to a minimum of: £30,960 per year.

He qualified for the new entrant salary discount (Option E) because he is under the age of 26. Note that under Option E he may only be granted permission for 4 years, although he may be granted permission under another option subsequently.

He met the English Language requirement as he had a degree-level qualification which was taught or researched in English.

Under this immigration route, he is eligible to bring a dependent (spouse, partner or child aged under 18 years) subject to the applicable requirements.

**The government fees for a 3-year period of sponsorship are as follows:**

|                              |        |                    |
|------------------------------|--------|--------------------|
| Certificate of Sponsorship   | £239   | Paid by employer   |
| Immigration Skills Charge    | £1092  | Paid by employer   |
| Entry Clearance Application  | £719   | Paid by job seeker |
| Immigration Health Surcharge | £3,105 | Paid by job seeker |

The Immigration Skills Charge may be higher for large companies. Fees will change depending on length of sponsorship. This can be any length between 6 months and 5 years, but an initial 3 years is most common.

Passportia can prepare the application for the employer and job applicant for a total fee of £750, subject to their standard terms. After 5 years residence in the UK a skilled worker can apply for indefinite leave to remain.
